

## Eastminster Preschool 2017-2018 Preschool/VPK

### Enrollment Options and Tuition Rates

#### Toddler 1 Class (Ages 18 months- 24 months)

3 Day (MWF) 9am-12pm	\$260/month
5 Day (M-F) 9am-12pm	\$360/month
Full Time (M-F) 8am-6pm	\$660/month

**Early Care** is available to ALL students from 8am-9am on a drop in basis. \$10/day will be billed to your account. Early care is included in the full time tuition cost.

#### Toddler 2 Class (2 years old by 9/1/17)

3 Day (MWF) 9am-12pm	\$260/month
5 Day (M-F) 9am-12pm	\$360/month
Full Time (M-F) 8am-6pm	\$660/month

**Lunch Bunch** is available to ALL students who would like to extend the day from 12-2pm. Tickets may be purchased 12 for \$84 or 20 for \$130. A peanut free lunch must be provided from home for Lunch Bunch.

#### Three Year Old Class (3 years old by 9/1/17)

3 Day (MWF) 9am-12pm	\$260/month
5 Day (MWF) 9am-12pm	\$360/month
Full Time (M-F) 8am-6pm	\$660/month

**Extended Day** option from 2-6pm is built into the Full Time schedule. In case of emergency, we will be happy to accommodate your child for a \$30/day drop in charge.

**Annual Registration Fee:** \$100 per child or \$150 if you are registering more than one student. There is no mandatory fee for VPK but a \$65 voluntary activity fee is encouraged to cover costs for supplies which are not covered by the State. This fee has already been included in Preschool tuition rates.

#### VPK Class (4 years old by 9/1/17)

There is no charge for the VPK portion of the school day (9am-12pm) for this state funded program.

VPK instructional hours are Monday- Friday 9am-12pm

#### VPK Extended Day Options

Your VPK student has the option to stay for Extended Day from 12pm-6pm for \$400/month.

When VPK is not in session (non-instructional days) Full Day option 8am-6pm \$50/day.

**\*\* A Tuition discount of 10% will be offered to families who have 2 or more students enrolled in tuition based programs\*\***

Lunch Bunch tickets are available to be purchased and students may be signed up for limited Lunch Bunch spots. This is on a first come, first serve basis so we may staff accordingly to family's needs.

Early Care is available to ALL students from 8am-9am for \$60/month. In case of emergency, we will be happy to accommodate your child for a \$10/day drop in charge.
